7-7: Review, Discussion and Possible Action by the Council on an Agenda Request by Tina Sparks requesting that City employees have the option to be paid via direct deposit.


7-8: Review, Discussion and Possible Action by the Council on an Agenda Request by Tina Sparks to allow the Municipal Court to have a City credit card.
