



IMPORTANT DATES
MAY 6, 2023, CITY OF LONE STAR GENERAL ELECTION

January 18, 2023	First day to file for place on the ballot or a declaration of write-in candidacy. Filings must be received by the City Secretary’s Office.
February 17, 2023	Last day for filing application for place on general election ballot (Must be received in City Secretary’s office by 5:00 pm).
February 21, 2023	Last day for a write-in candidate to declare candidacy in the general election. (Must be received in City Secretary’s Office by 5:00 pm.)
February 24, 2023	Last day for a ballot or write in candidate to submit a certificate of withdrawal. Drawing for order of names on ballot at 5:00 pm, City Hall. (All candidates will be notified if change in date/time occurs.)
March 22, 2023	Last day to mail ballots to FPCA voters and other voters who are eligible for early voting because they are voting from outside the U.S.
April 6, 2023	Last day to register to vote for May 6 th election. (Must register with Voter Registrar of the county of residence.) 1 st report of Campaign Contributions and Expenditures (Candidate/ Officeholder Campaign Finance Report due. This is the report made 30 days prior to election day. (Must be received by City Secretary by 5:00 pm).
April 24 – 28, 2023	Early voting by personal appearance at City Hall – 8:00 am – 5:00 pm
April 25, 2023	Last day to accept application for a ballot to be voted by mail. Must be received by 5:00 pm.
April 28, 2023	2 nd report of Campaign contributions and expenditures (Candidate/ Officeholder Campaign Finance Report) due. This is the report made 8 days prior to election day. (Must be received by City Secretary by 5:00 pm)

May 1 – 2, 2023	Early Voting by personal appearance at City Hall - 8:00 am – 5:00 pm. MAY 2nd IS THE LAST DAY FOR EARLY VOTING BY PERSONAL APPEARANCE.
May 6, 2023	***ELECTION DAY*** 7:00 am – 7:00 pm at Lone Star Fire Hall
May 9 – 17, 2023	Period for official canvass, oaths of office by newly elected officers, unless runoff election is necessary. All candidates will be notified of specific date/time of canvass and oaths. Drawing for place on runoff ballot, if necessary, after official canvass.
July 17, 2023	Last day for timely filing of semi-annual report of contributions and expenditures by candidates and officeholders due by 5:00 pm.
